IT IS AGREED with effect on and from the date of this Deed, as follows:-

- 1. The Employer agrees to participate in the Plan as a Participating Employer and to pay the amount requested by the Trustee as the premium or premiums for the Trustee to apply in the purchase of a Policy or Policies and confirms that it has provided appropriate notice to the Sponsor of its participation.
- 2. The Employer further agrees and declares that it will at all times and in all respects be bound by and comply with the terms and conditions of the Plan as set out in the Trust Deed.
- 3. The Employer undertakes to indemnify and at all times to keep the Sponsor and the Trustee and each of them respectively indemnified against all actions, proceedings, claims and demands brought or made against the Sponsor and/or the Trustee and all losses, damages, liabilities, costs and expenses incurred or sustained by the Sponsor and/or the Trustee as a result of or in connection with any breach by the Employer of any of its obligations under this Deed and the Trust Deed.
- 4. This Deed shall be read as one with the provisions of the Trust Deed and shall be governed and construed in accordance with the laws of England and Wales.
